- SC3 There is no threatening environment at work.
- SC4 I am confident in my physical ability to handle competing demands at work.
- SC5 I am confident in my ability to think clearly at work.
- SC6 I am confident in my ability to display the appropriate emotions at work.
- SC7 I am confident that I can handle the physical demands at work.

2. Supportive leadership (5-point Likert Scale; 1-Strongly Disagree, 5-Stronlgly Agree)

- SL1 My leader would use his/her power to help me solve problems in my work regardless of how much formal authority he/she has into his/her position
- SL2 My leader would 'bail me out' at his or her expense regardless of the amount of formal authority my leader has
- SL3 I have enough confidence in my leader that I would defend and justify his/her decision if he/she were not present to do so
- SL4 My working relationship with my leader is extremely effective
